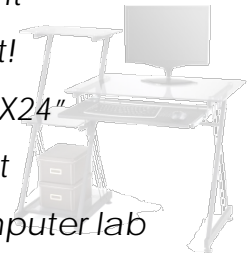

II. Sponsor the Coffee/Beverage Station

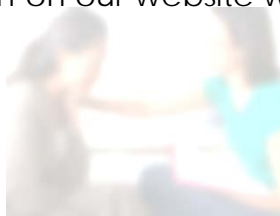

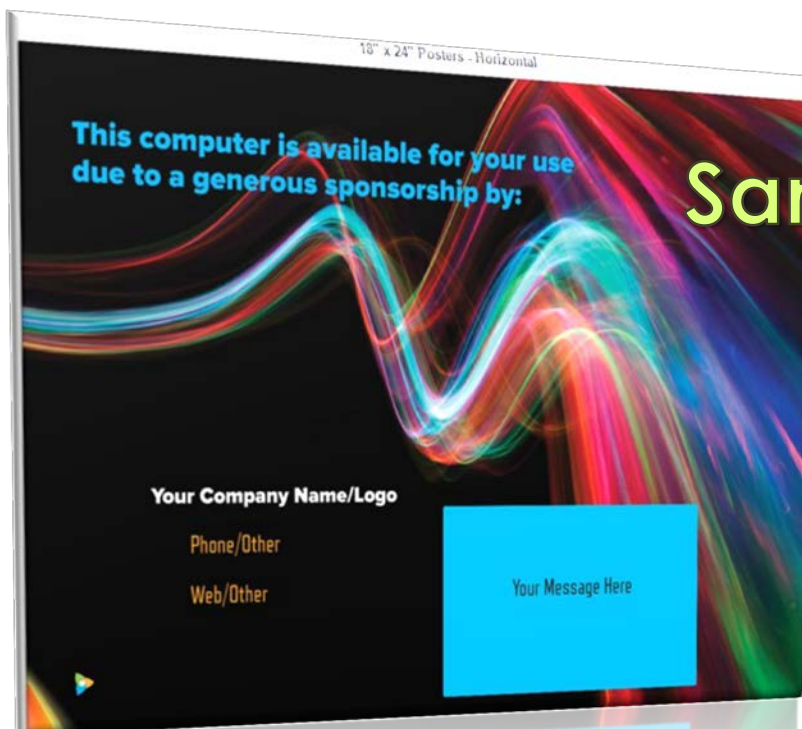
III. Sponsor a Meeting Room
